

CONTEST RULES & REGULATIONS ("Rules")

NO PURCHASE IS NECESSARY TO ENTER OR WIN A PRIZE IN THIS CONTEST. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS CONTEST IS CONDUCTED IN ONTARIO AND IS SUBJECT TO THE LAWS OF THE PROVINCE OF ONTARIO. BY ENTERING THE CONTEST, YOU ACCEPT AND AGREES TO BE BOUND BY THESE RULES, VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW.

1. SPONSOR:

This Contest is sponsored by [Tribute Communities Inc] (the "Sponsor")

2. CONTEST PERIOD:

Harlem Globetrotter Giveaway Contest (the "Contest") begins on **April 5, 2018** at 11:59:59 a.m. Eastern Time ("ET") and ends on **April 12, 2018** at 11:59:59 a.m. ET ("Contest Period").

3. ELIGIBILITY:

To be eligible to win this Contest, the you must be a legal resident of Ontario and have reached the age of 18 at the time of entering this Contest and have complied with the Rules of the Contest as set out herein.

4. ENTRY:

NO PURCHASE NECESSARY. To participate in this Contest, you must have a valid Instagram account. If you do not have a Instagram account you can visit Instagram.com (each a "Website", collectively the "Websites") and follow the instructions provided to register for a free account.

To enter the Contest using:

- (a) **Instagram, during the Contest Period you must be following the Tribute Communities account** from your Instagram account and must comment on our "**Harlem Globetrotter**" post, describing who you will bring to the event. To be eligible, any comment submitted must also comply with all applicable Instagram Terms and Policies, copies of which are available at the Website.

A comment submitted or posted by you describing who you will bring in response to the Tribute Communities "**Harlem Globetrotter**" Post is hereinafter defined as an "**Entry**" and multiple comments are hereinafter defined as "**Entries**".

You shall be limited to one (1) Entry into the Contest, and an Entry will have been submitted when you submit an Entry in one (1) of the formats described above and these Rules. Any Entry that does not follow one of the above formats as determined by the Sponsor, in its sole and absolute discretion, will be ineligible for entry in this Contest. Entries must not infringe, misappropriate or violate any third party's rights, including, without limitation, copyright, trademark, right of publicity, right of privacy or trade secret and not contain any content that is offensive, illegal, obscene or that is otherwise objectionable to Sponsor, in its sole discretion. Further, you confirm by submitting an

Entry that no other person has any intellectual property rights or other interest in the Entry submitted and, further, confirm that in the event you are a winner in the Contest, acceptance of the Prize will not result you breaching the terms of any other agreement with a third party. For greater certainty, you shall indemnify the Released Parties (as hereinafter defined) against any liability for any claims and associated costs that may be brought against them by any third parties with respect to any intellectual or other property rights in the submitted Entry.

You may be asked to consent to receive further electronic communications (for example, promotional posts, or emails) in connection with this Contest as well as for upcoming promotions and information about the Sponsor. 5. ENTRY SUBMISSION:

There is a limit of one (1) Entry Instagram account permitted during the Contest Period. You can only use (1) Instagram account to submit 1 entry each. Each Entry must be original and cannot be a duplicate, in whole or in part, of an Entry previously submitted in this Contest by you on that social media platform or by any other person. If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor), that you have attempted to: (i) obtain more than one (1) Entry per Instagram account during the Contest Period; and/or (ii) use (or attempt to use) multiple names, identities, accounts, and/or any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or disrupt this Contest, then the Sponsor may disqualify you from the Contest in the Sponsor's sole and absolute discretion. The Released Parties are not responsible for late, lost, misdirected, delayed, incomplete or incompatible Entries (all of which are void).

All Entries are subject to verification by the Sponsor at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification): (a) for the purposes of verifying your eligibility to participate in this Contest; (b) for the purposes of verifying the eligibility and/or legitimacy of an Entry entered (or purportedly entered) for the purposes of this Contest; and/or (c) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with these Rules. The sole determinant of the time for the purposes of a valid Entry in this Contest will be the Contest server machine(s).

6. PRIZES:

7. WINNER SELECTION:

Prize: On **April 12, 2018** (“**Prize Selection Date**”) at the offices of the Sponsor commencing at approximately 12:00 p.m. ET, a random drawing will be held by the Sponsor to select a potential winner of the Prize from among eligible Entries received via Instagram. Odds of winning the Prize will depend upon the number of eligible Entries received by the Sponsor during the Contest Period via Instagram.

any injury or damage to your or any other person's computer or other device related to or resulting from participating in the Contest; and/or (v) any combination of the above.

In the event of a dispute regarding who submitted an Entry, Entries will be deemed to have been submitted by the authorized account holder of the Instagram, account at the time of entry. “**Authorized account holder**” is defined as the person who is assigned a Facebook or Instagram account by Facebook or Instagram as applicable. You may be required to provide proof (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification) that you are the authorized account holder of the Facebook or Instagram account associated with the Entry in question.

The Sponsor reserves the right, in its sole and absolute discretion, and without prior notice to adjust any of the dates and/or timeframes stipulated in these Rules, to the extent necessary, for purposes of verifying compliance by you, another Entrant, or Entry with these Rules, or as a result of any technical or other problems, or in light of any other circumstances which, in the opinion of the Sponsor, in its sole and absolute discretion, affect the proper administration of the Contest as contemplated in these Rules, or for any other reason.
